# 2017 Hancock Prospecting Australian Short Course Championships SWIMMING AUSTRALIA MEDIA ACCREDITATION TERMS AND CONDITIONS (Terms and Conditions) Accreditation

- Swimming Australia Ltd (SA) owns all proprietary rights in the 2017 Hancock Prospecting Australian Swimming Championships (Event) including in relation to media accreditation for the Event (Accreditation). The Event will be held at SA Aquatic & Leisure Centre (Venue).
- 2. To be granted Accreditation for the Event you must:
  - a. complete the media accreditation application and submit to SA by 5.00pm 2 October 2017;
  - b. submit a current headshot photo; and
  - c. sign and date these Terms and Conditions where indicated.
- 3. You acknowledge and agree that SA may, in its sole discretion:
  - a. grant your Accreditation; or
  - b. reject your request for Accreditation.
- 4. Where SA rejects your request for Accreditation it is not required to provide you with reasons for such decision. A decision to reject Accreditation is not subject to appeal.
- 5. You acknowledge and agree that SA may, in its sole discretion and at any time and for any reason, revoke your Accreditation. Where SA revokes your Accreditation it is not required to provide you with reasons for such decision and the decision is not subject to appeal.
- 6. Where SA rejects your request for Accreditation or revokes your Accreditation, it is not liable in any way to you or to any other person for such decision.
- 7. Accreditation is personal, not-transferable and must be displayed at all times while in areas requiring accreditation and is valid only in areas as specified by SA from time to time. You must not transfer your Accreditation.

### **Obligations**

- 8. In consideration of SA granting you Accreditation, you must:
  - a. comply with any relevant terms and conditions of entry to the Venue as in force from time to time;
  - b. comply with all SA rules, regulations, policies and procedures as in force from time to time;
  - c. comply with and follow all lawful directions of SA or its employees, officers or agents acting on its behalf, including in relation to these Terms and Conditions;
  - d. comply with all relevant laws regarding the sourcing and use of any media rights associated with SA, the Event and the Venue:
  - e. not breach the intellectual property rights of any person involved in the Event; and
  - f. not conduct yourself in a manner unbecoming and must not bring yourself, SA or the sport of swimming into disrepute.

## Use of images

9. Any photographic images taken are for the purpose of reproduction in newspapers and websites of the applicant's media organisation and in subscription to its syndications service. Images captured from within the Venue must be still images only and not moving images or audio. For the avoidance of doubt, rights to taking moving images and audio from within the Venue are reserved for the host television, radio broadcasters and online rights holders. Photographic images taken at the event must not be sold for commercial use without the express permission of SA. Any images sold to readers must be sold on the basis that they are marked for personal consumption only and are not to be used commercially. As set out above, Network Seven is the official Host Broadcaster for the 2017 Hancock Prospecting Australian Short Course Championships. You agree to provide Network Seven, upon request, with access

to event still images with rights to use up to 10 images each day of the event free of charge to use within the broadcast and digital platforms to promote the event and Network Sevens coverage of the event. Network Seven will provide the appropriate credits to the image source.

## Indemnity

- 10. By signing these Terms and Conditions you acknowledge and agree that you undertake to perform media services and activities in relation to the Event and move around the Venue voluntarily and at your own risk.
- 11. In consideration of SA granting you Accreditation for the Event, to the extent permitted by law you agree to:
  - a. release and will release SA, its employees, officers and agents from all claims that you may have or may have had but for this release arising from or in connection with your Accreditation or any decision by SA to reject or revoke your Accreditation; and
  - b. indemnify and will keep indemnified to the extent permitted by law SA and each of its employees, officers and agents against any loss, claim, expense or damage to SA or any of its employees, officers and agents arising or resulting from your breach of these Terms and Conditions, your participation in the Event or the rejection or revocation of your Accreditation by SA, save that the above releases and indemnities shall not apply to the extent that the loss, damage or injury that is the subject of a claim is caused or contributed to by the grossly negligent act or omission of SA.

# **Privacy**

12. Personal information provided in this application is necessary for the conduct and management of the Event, and it is collected in accordance with SA's Privacy Policy (available from <a href="www.swimming.org.au">www.swimming.org.au</a>). You agree SA may use or disclose your personal information for the purposes of administering the Event and SA or otherwise in accordance with the SA Privacy Policy. SA may share your personal information with third parties such as affiliates and other organisations involved in the Event; companies engaged by SA to carry out functions and activities on SA's behalf including direct marketing; SA's professional advisers, including SA's accountants, auditors and lawyers and SA's insurers. Information is not generally disclosed to anyone outside Australia. The SA Privacy Policy contains information about how you may access and request correction of your personal information held by SA or make a complaint about the handling of your personal information, and provides information about how a complaint will be dealt with by SA. Your application for Accreditation may be rejected if the requested information is not provided. If you do not wish to receive promotional material from SA sponsors and third parties you must advise SA in writing or via the opt-out procedures provided in the relevant communication.
